COMPREHENSIVE EXAM

Compulsory subject¹

The Concept, Subject, and Elements of Public Governance Science; Methods of Research on the State and Public Administration

The present course requirements shall apply to doctoral students who begin their training period in the Doctoral School of Public Administration Sciences in the academic year 2024/25 or thereafter.

Requirements

Comprehensive knowledge of the studies included in the specified literature.

Exam Format

The candidate provides an oral overview of the research methods and key theses of one or more studies listed in the literature selected according to the procedure determined by the Examination Board. Following this, based on the questions posed by the Examination Board regarding the study, the candidate demonstrates their knowledge of public administration science, as well as her/his research habitus, such as argumentation, analytical, logical, and scientific communication skills.
