- o Research: contribution to the development of education materials, involvement in the activities of research working groups, establishment of new research projects and working groups, efforts aimed at publications and academic organizing activities.

The applicant prepares a preliminary academic programme that is in line with the University's strategy and corresponds to its aims while containing the applicants ideas on the above mentioned activities.

- o The "International Chair" will provide a mid-term and a final narrative report in English on the accomplishments achieved
- o The "International Chair" is required to teach at least 6 hours/week
- o The "International Chair shall summarise his/her experiences that he/she has gathered and put forward proposals concerning the possible ways of improving the "International Chair" program

- o employment and gross 700,000 HUF (approx. 2220 EUR or 2420 USD) salary according to the public service rules in Hungary;
- o one-time cost of international round trip between residence and Budapest;
- o housing benefit;
